BID CONDITIONS AND INFORMATION

1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity must be cleared with contact person for the bid before the closure date.

4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorizing the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorized to sign it for and on behalf of the bidder.

5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the *Tender Box at the Garden Route District Municipality by not later than 11h00 on 16 JULY 2024*
- (b) Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.

6 Opening, Recording and Publications of Bids Received.

- i. Bids will be opened in public immediately after the bid closure date, or at such time as specified in the bid documents.
- ii. If requested by any bidder present, names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out aloud.
- iii. Bids received in time recorded and entered in a register which is open for public inspection.

7 Tax Clearance Certificate / SARS TCS Pin

- i. Compulsory requirement to submit active, valid Tax Compliance Status Pin (TCS) for independent verification of Tax status as at Bid evaluation stage.
- ii. Bids submission not supported by a valid SARS TCS Pin will be non-compliant.
- iii. Consortia / joint ventures /sub-contractors are involved; each party must submit individual SARS TCS Pin.
- iv. It is incumbent upon the bidder to ensure their own Tax Compliance status is maintained for the duration of Bid Validity period; non-tax compliant bidders will be disqualified.

8 Evaluation of Bids

Bids will be evaluated in terms of their responsiveness to the bid specifications and requirements as well as such additional criteria as set out in the bid documents.

The Garden Route District Municipality reserves the right to withdraw any invitation to submit a bid and/or to re-advertise or to reject any bid or to accept a part of it. The Garden Route District Municipality does not bind itself to accepting the lowest bid.

10 Registration on Accredited Supplier Database

It is expected of all prospective service providers who are not yet registered on the Central Supplier Database to register online (www.csd.gov.za) and verify their company information at Garden Route District Municipality Database Department. The Garden Route District Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

12 Stamp and Other Duties

The successful bidder will be liable for all duties and costs on legal documents resulting in the establishment of a contract and for the surety and retentions.

13 Language of Contract

The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.

14 Procurement Policy

Bids will be awarded in accordance with the Preferential Procurement Policy of Garden Route District Municipality, pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.

15 Expenses Incurred in Preparation of Bid

The Garden Route District Municipality shall not be liable for any expenses incurred in the preparation and submission of the bid.

16 Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

17 Validity Period

Bids shall remain valid for 120 days after the bid closure date.

18 General and Special Conditions of Contract

The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

19 Municipal Rates, Taxes and Charges

- i. The bidder to provide their municipal account of rates and taxes of both the Bidding entity and its directors in its Bid Document submission.
- ii. Any bidder which is or whose directors are in arrear with their municipal rates and taxes due to any Municipality within South Africa for more than three months and have not arranged for a settlement before the bid closure date will be disqualified.
- iii. Bids submission not supported by a recent municipal account will be non-compliant. In the event of leasing, a valid lease agreement <u>must</u> be attached to the bid document.
- *iv.* A Tenderer must submit a Municipal Account for their primary business location or valid lease agreement, as per address indicated in the bid document, to claim preference points for locality.
- v. Failure to submit a valid Municipal Account or Lease agreement will result in 0 preference point allocation for locality.

20 Contact with Municipality after Bid Closure Date

21 B-BBEE Supplier Bid Declaration

 6.1 and failure on the part of a bidder to complete mentioned bullet points, will be interpreted to mean that preference points for B-BBEE status level of contribution are not claimed and you will not receive any points.
- ii. Bids submission not supported by a B-BBEE certificate / sworn affidavit will be non-compliant.
- iii. Joint Ventures and Consortiums to submit a valid B-BBEE certificate in the name of the Joint Venture or Consortium.

GARDEN ROUTE DISTRICT MUNICIPALITY TERMS OF REFERENCE

1. **INTRODUCTION**

1.1 A successful bidder will be expected to supply and deliver Safety Shoes to the Garden Route District Municipality for the contract period of 1 years ending 30 June 2025.

2. **SCOPE**

2.1 <u>Time</u>

Lead time will be **15** working days from date of order. If tenderer cannot supply within the specified lead time, order will be cancelled and second service provider will be contacted.

2.2 **Pricing**

- 2.2.1 All prices must include delivery and off-loading at respective stores mentioned in 4.1 below and must include VAT.
- 2.2.2 Price per item must include delivery to all three Depots listed in 4.1.
- 2.2.3 Prices should be fixed for a period of 1 years ending 30 June 2025.

2.3 Quality and quantities

- 2.3.1 The manufacturer stated on the price schedule must remain the same over the one-year period, unless it has closed down or for similar reasons.
- 2.3.2 Quality test: The Municipality may from time to time test the quality of the products and non-compliance with the original specifications may result in the termination of the contract. Should the Municipality suffer any losses due to substandard quality products (as agreed to) the supplier will be held responsible.
- 2.3.3 All product items should carry (minimum of one year) guarantee. Defects will be replaced at the expense of the supplier. The supplier will be responsible to ensure that the products are replaced and delivered.

3. **SAMPLES**

3.1 The successful bidders will be required to supply sample of the products.

3.2 The samples will be kept by Garden Route District Municipality Roads Department to verify/ compare quality of future products.

4. **DELIVERIES**

- 4.2 Delivery of products to the designated delivery addresses as indicated above must include the off-loading thereof at the supplier's own risk and cost.
- 4.3 Delivery must take place on normal business days between 08:00 and 16:00. Non-compliance hereto, could lead to the rejection of the delivery and the Garden Route DM will not be held responsible for any cost incurred.
- 4.4 Bidders must supply and ensure the availability of their own labour for the off-loading of the products at the designated municipal stores.

5. ORDERS, INVOICING AND DELIVERY NOTES

- 5.1 The District Municipality will place orders as and when required during the contract period.
- 5.2 An official order must be issued before any delivery may be made to the District Municipality.
- It may be required from the supplier to keep stock of products or to ensure that full delivery takes place according to the order quantities.
- 5.4 All deliveries should be accompanied by at least a delivery note. The Garden Route DM reserves the right to reject the delivery without a delivery note.
- 5.5 Preferably an invoice or pro-forma invoice must accompany all deliveries.
- 5.6 Incorrect invoicing will delay payment and the supplier will be held responsible for correction and resubmission of correct invoices and statements.
- 5.7 Bidders should ensure that orders, delivery notes and invoices correspond.
- 5.8 The tender is not for a bulk order but as and when needed by the Department.

SPECIFICATIONS

SUPPLY AND DELIVERY OF PERSONAL PROTECTIVE FOOTWEAR.

This tender covers the supply and delivery of protective clothing and footwear as detailed in the following specifications. The quantities reflected in the pricing schedule are estimated quantities only and there is no guarantee that all the quantities reflected in the schedule will be utilized. Relevant supporting documentations must accompany all bid documentation (SANS Certificate of Conformance from Manufacturer, etc.).

1. Footwear - Safety Shoes/boots: (Unisex)

a) The boots/shoes will be used by workers involved in routine road maintenance, gravel road maintenance and construction, bitumen works and vegetation clearing. It is therefore required that the shoes offered against this tender must be suitable for this working environment and be suitable for working on hot tar/bitumen and premix. The shoe must conform to SANS specifications and carry the SANS mark of conformance.
Boot must carry the SABS/SANS ISO 20345 certified mark

General Requirements

- a). Extra Wide Fitting Steel Toe Cap to withstand an impact load of 200 joules
- b). Steel Toe Cap design to provide easier flex (and more comfort to bridge of the foot)

General Conditions of Contract

1. Definitions

- 1. The following terms shall be interpreted as indicated:
- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the provider bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
