6. DISCUSSION

6.1 Background

In terms of Section 54 of the Local Government: Municipal Structures Act, 1998 (the Act), the Garden Route District Municipality qualifies to have an Executive Mayor. Section 55 of the said Structures Act, Provides that if a municipal Council chooses to have an executive mayor, it must elect an executive mayor from among its members. The MEC of Local Government in the Western Cape Province has determined that the Garden Route District Municipality is a "mayoral executive system type of Municipality.

The Speaker presides over the election of the Executive Mayor, and will advise and direct the election process from the Chair.

The Executive Mayor, Ald M Booysen submitted his resignation on 08 June 2024, this created a vacancy and therefore a new Executive Mayor has to be elected.

6.2 Discussion

The procedure for the election of an Executive Mayor is found in schedule 3 of the Act. The procedure begins with nominations of candidates which must be signed by a proposer, a seconder and the nominated Councillor.

The voting for the Executive Mayor must be conducted through a secret ballot.

6.3 Financial Implications

The office of the Executive Mayor has been budgeted for in the 2024/2025 financial year.

6.4 Linkage to Strategic Objective(s)

Good Governance.

6.5 Legal Implications

Local Government: Municipal Structures Act, Act 117 of 1998, specifically section 54, 55 and schedule 3 provides the process to be followed.

6.6 Staff Implications

The Executive Mayor's office will have to be capacitated by employment of support staff.

6.7 Previous / Relevant Council Resolutions:

Council, at its inauguration meeting dated 25 November 2021, elected Ald G van Niekerk, as the Deputy Executive Mayor.

6.8 Risk Implications

If the Council does not elect the Executive Mayor, that will result in non-compliance with legislation. There are specific governance functions allocated to the Executive Mayor. It is therefore not desirable that this [position is left vacant.

The procedure set out in Schedule 3 of the mentioned Act also applies to the election of an Executive Mayor.

A relevant Nomination Form is supplied separately on which nominations must be submitted when called for by the Speaker.

6 DISCUSSION / CONTENTS

6.1 Background

The powers and functions (executive authority) of a municipality are foremost enacted in Sections 156 and 229 of the Constitution of the Republic of South Africa, 1996, which is the supreme law of the Republic.

The general empowerment provision of a municipality is enacted in Section 8 of the Local Government: Municipal Systems Act, 2000, which reads as follows:

“CHAPTER 3

MUNICIPAL FUNCTIONS AND POWERS

8. General empowerment.-(1) *A municipality has all the functions and powers conferred by or assigned to it in terms of the Constitution, and must exercise them subject to Chapter 5 of the Municipal Structures Act.*

(2) *A municipality has the right to do anything reasonably necessary for, or incidental to, the effective performance of its functions and the exercise of its powers.”*

Attached hereto kindly find Chapter 5 of the Local Government: Municipal Structures Act, 1998, as Annexure B.

The Constitution also states in Section 160(1)(c) that a Municipal Council may elect committees, subject to national legislation. Said Section 160 is attached hereto as Annexure C.

6.2 Discussion

In order to efficiently and effectively exercise the powers and functions of the municipality a Committee system is herewith proposed as envisaged in Section 33 of the mentioned Structures Act, which reads as follows:

“33. Criteria for establishment of committees.- A municipality may establish a committee provided for in this Act if-

- (a) the municipality is of a type that is empowered in terms of this Act to establish a committee of the desired kind;
- (b) the establishment of the committee is necessary, taking into account-

- (i) the extent of the functions and powers of the municipality;
 - (ii) the need for the delegation of those functions and powers in order to ensure efficiency and effectiveness in their performance; and
 - (iii) the financial and administrative resources of the municipality available to support the proposed committee; and
- (b) in the case of the establishment of an executive committee, the municipality has more than nine councilors."

It is very important to note Section 160(8) of the Constitution, which reads as follows:

"(8) Members of a Municipal Council are entitled to participate in its proceedings and those of its committees in a manner that-

- (a) allows parties and interests reflected within the Council to be fairly represented;
- (b) is consistent with democracy; and
- (c) may be regulated by national legislation."

In terms of subsection (a) as quoted above, all Committees of the Municipal Council must thus be fairly (proportionally) representative of all (political) parties and interests.

Except if otherwise indicated below, all Committees of the Municipal Council are established in terms of Section 79 of the Structures Act.

It must however be noted that the Mayoral Committee is not a Committee of the Municipal Council but a Committee appointed by the Executive Mayor in terms of Section 60(1)(a) of the Structures Act.

The types of Committees proposed are:

Portfolio Committees as envisaged in Section 80 of the Structures Act.

There should be seven (7) Portfolio Committees and the Chairperson of each Committee shall be appointed by the Executive Mayor from her/his appointed Mayoral Committee, of which the Deputy Executive Mayor is a member. The main purpose of the Portfolio Committees is to assist the Executive Mayor in executing his/her functions and powers. The functions of every Portfolio

Committee must be determined by the Municipal Council as stipulated in Section 79(2)(a) of the Structures Act.

6.3 Financial Implications

The municipality has budgeted for the thirty five (35) Councillors in the 2024/2025 financial year.

6.4 Legal Implications

The Municipality must establish its Council in terms of the legislation.

6. DISCUSSION / BACKGROUND**6.1 BACKGROUND**

Section 60 of the Local Government Municipal Structures Act, 1997 (Act 117 of 1998) provides:

- "1) *If the municipal council has more than nine members, its executive mayor-*
- (a) *must appoint a mayoral committee from among the councillors to assist the executive mayor*
 - (b) *may delegate specific responsibilities to each member of the committee;*
 - (c) *may delegate any of the executive mayor's powers to the respective members; and*

- (d) *may dismiss a member of the mayoral committee*
- 2) *The mayoral committee must consist of the deputy executive mayor (if any) and as many councillors as may be necessary for effective and efficient government, provided that no more than 20 percent of the councillors or 10 councillors, whichever is the least, are appointed.*
 - 3) *Those of the executive mayor's powers and functions as may be designated by the municipal council, must be exercised and performed by the executive mayor together with the other members of the mayoral committee.*
 - 4) *The members of a mayoral committee remain in office subject to the subsection (5) and section 26 for the term of the executive mayor who appointed them.*
 - 5) *If the executive mayor vacates office, the mayoral committee appointed by that executive mayor dissolves.*

The Garden Route District Municipality does not currently have a Mayoral Committee since the resignation of erstwhile Executive Mayor, and action which led to dissolution of Mayoral committee.


